- Facilitate monthly meetings of your team.
- Liaise with GSA VP Academic and stakeholders.
- Support your team in planning and executing academic events.
- Review and refine initiatives for effectiveness.
- Represent graduate student interests within the academic community.

Chair Time Commitment: 10 – 15 hours per month

Chair Honorarium: Eligible for up to \$1,000 per year

#### Vice Chair Responsibilities

- Provide support to the chair in various tasks as needed.
- Lead committee meetings in the absence of the chair.
- Serve as a secondary point of contact for stakeholders and the GSA VP Academic

- Ensure smooth transition and continuity of initiatives in the absence of the chair.
- Step in to represent graduate student interests when required.

With transparency as our cornerstone, the AC develops and adheres to selection criteria and evaluation procedures. Made of over 80 members, the AC strives to create a culture of recognition and support for academic excellence.

#### **Chair Responsibilities**

- Provide strategic direction and oversight to the committee.
- Ensure transparency and integrity in the awards process.
- Facilitate meetings and maintain effective communication among members.
- Guide the development of selection criteria and evaluation procedures.
- Represent the committee and communicate with stakeholders, including the GSA and award applicants.
- Monitor the quality and consistency of award adjudication and recommendation processes.
- Address any conflicts or concerns that arise during the awards process.
- Identify areas for process enhancement and implement improvements as needed.
- Provide regular updates and reports to the GSA VP Academic on committee activities and outcomes.

Chair Honorarium: Eligible for up to \$4,500 per year
