

## Summary

During the reporting period from early September to December 2025, the Vice President Academic portfolio advanced significant work across awards administration, academic events, bursary delivery, and university level committee engagement.

The Awards Committee progressed multiple award cycles, including the Citizenship Award, Inclusion Scholarship, GSA Bursary, and Professional Development Grant. Adjudication for the awards mentioned were completed and the funds for the GSA Bursary and the PDG will be disbursed in the winter. A successful Awards Information Session was held and recorded for wider student access. Implementation of the new Good Grants platform required timeline adjustments and additional configuration, with ongoing challenges related to volunteer recruitment for bursary adjudication due to high application volumes. These challenges pushed the disbursement of the GSA Bursary and PDG into the Winter.

The Academic Events Committee advanced its term activity plan, hosted volunteer orientations, and successfully engaged students during Academic Integrity Week. Planning continued for workshops and the Peer Beyond Graduate Research Conference, including securing the Collision Space at Hunter Hub for the poster session and the all-new plenary session addition. Additional initiatives included the development of the Discovery Dialogues Podcast to highlight graduate student research and entrepreneurial work, which will start this Winter term.

In student financial support, the Graduate Support and Emergency Bursary programs administered by the Office of the Registrar remained highly active. Emergency funding and support bursaries were adjudicated and disbursed, supporting hundreds of students and allocating substantial funds while maintaining a remaining balance for future needs. The period also included policy and operational discussions related to bursary adjudication capacity and process sustainability.

Committee work remained extensive. The VPA contributed to discussions at the General Faculties Council, addressing campus safety, mental health, federal research funding, tuition consultations, assessment principles, policy revisions, continuing education growth, sustainability performance, and long-term institutional planning. Engagement also continued through the Assessment Principles Working Group, Student Accommodation Working Group, Graduate Academic Program Subcommittee, Course Feedback Implementation Working Group, Experiential Learning Advisory Committee, and the VPTL Search Committee. These committees addressed topics ranging from assessment reform and accommodation policy review to digital transformation, generative AI, experiential learning, and course feedback system implementation.

Overall, the reporting period reflects sustained advocacy for graduate students, strong governance participation, continued enhancement of awards and bursary systems, and active contribution to institutional academic and policy development.
